FIRST QUARTERLY GROSS DOMESTIC PRODUCT ESTIMATE, FOURTH QUARTER OF 2024

The estimation of the gross domestic product (GDP) for the fourth quarter of 2024 is presented by major categories of expenditure and according to the NKD 2007 activity sections.

The quarterly GDP data focus on short-term movements of the economy, while the main purpose of the quarterly GDP estimate is the calculation of real growth rates.

The estimate shows that the quarterly GDP in real terms increased by **3.7%** in the fourth quarter of 2024, as compared to the same quarter of 2023.

The seasonally adjusted quarterly GDP showed a positive rate of change of 1.4% compared to the previous quarter and it increased by 3.6% in real terms compared to the same quarter of 2023.

On the expenditure side a real growth is visible in all of the GDP categories.

Table 3 shows the real growth rates of the quarterly gross value added (GVA) according to the NKD 2007 activity sections based on non-adjusted data.

The first estimate shows that the quarterly GVA increased in real terms by 3.5% in the fourth quarter of 2024, as compared to the same quarter of 2023, based on non-adjusted data.

The increase in GVA was mainly influenced by an increase in real value added in Wholesale and retail trade, Transportation and storage, Accommodation and food service activities and Construction.

In addition to the first estimate of the GDP for the last quarter of 2024, the preliminary estimate of the GDP for 2024 was also calculated, which shows a growth of **3.8%**.

According to the first estimate, the annual GVA in 2024 was 3.6% higher in real terms than in 2023.

In Statistics in Line, the data by major categories of expenditure and according to the NKD 2007 activity sections at current prices, constant prices of the previous year, constant prices of the reference year (2021 = 100) and real growth rates are presented.
