TOURISM SATELLITE ACCOUNT FOR THE REPUBLIC OF CROATIA, 2022



The gross value added of tourism industries in 2022 amounted to 104 069 million kuna (Table 4). The gross value added of tourism industries represents 24.53% of the total gross value added realised in 2022. Following the calculation of the tourist share in the production for each of the tourism industries and other industries, the tourism direct gross value added has been calculated. It amounted to **49 095** million kuna in 2022 and accounted for **11.57%** of total gross value added.

The tourism direct gross domestic product in 2022 amounted to **62 038** million kuna and its share in total gross domestic product amounted to **12.18%**.
