

**PROMET U ZRAČNIM LUKAMA  
U PROSINCU 2021.  
TRAFFIC IN AIRPORTS  
DECEMBER 2021**

U prosincu 2021. ukupan promet putnika u hrvatskim zračnim lukama iznosio je 216 tisuća putnika ili njih 299,6% više nego u prosincu 2020., kada je ostvaren promet od samo 54 tisuće putnika zbog širenja bolesti COVID-19. Za usporedbu, u prosincu 2019. ostvaren je promet od 307 tisuća putnika. U prosincu 2021. ostvareno je 70,3% prometa putnika iz prosinca 2019., dok je ukupno u 2021. ostvareno 41,3% prometa putnika iz 2019.

Najveći promet putnika ostvarila je zračna luka Zagreb, sa 178 tisuća putnika, što je više za 336,0% u odnosu na prosinac 2020., kada je prevezena 41 tisuća putnika (u prosincu 2019. prevezeno je 230 tisuća putnika), slijedi zračna luka Split, s 23 tisuće putnika (u prosincu 2020. prevezeno je 8 tisuća putnika, dok je u prosincu 2019. prevezeno 39 tisuća putnika) te zračna luka Dubrovnik, s 12 tisuća putnika (u prosincu 2020. prevezene su 4 tisuće putnika, dok je u prosincu 2019. prevezeno 35 tisuća putnika).

Najznatniji međunarodni putnički promet ostvaren je sa zračnim lukama Njemačke, 48 tisuća putnika, što je porast od 353,0% u odnosu na isto razdoblje 2020., kada je prevezeno 11 tisuća putnika.

Ukupan broj slijetanja i polijetanja zrakoplova u zračnim lukama u prosincu 2021. iznosio je 4 653, što je porast od 101,0% u usporedbi s prosincem 2020., kada je broj slijetanja i polijetanja iznosio samo 2 315. Ukupan broj slijetanja i polijetanja zrakoplova u zračnim lukama u prosincu 2019. iznosio je 4 886.

Ukupan promet tereta u zračnim lukama u prosincu 2021. iznosio je 882 tone, što je porast od 25,5% u usporedbi s prosincem 2020., kada je promet tereta iznosio 703 tone.

Od siječnja do prosinca 2021. u hrvatskim zračnim lukama ostvareno je 86 tisuća slijetanja i polijetanja zrakoplova, što je porast od 58,2% u odnosu na isto razdoblje 2020. U hrvatskim zračnim lukama u 2021. ukupno je ukrcano i iskrcano 4,7 milijuna putnika, što je porast od 121,5% u usporedbi s 2020. Ukupan promet tereta u zračnim lukama od siječnja do prosinca 2021. porastao je za 14,7% u odnosu na isto razdoblje 2020. te je iznosio 8,8 tisuća tona.

*The total traffic of passengers in Croatian airports amounted to 216 thousand in December 2021, which was 299.6% more than in December 2020, when the total traffic of passengers amounted to only 54 thousand due to the spread of the COVID-19. By comparison, in December 2019, the total traffic of passengers amounted to 307 thousand. The total traffic of passengers in December 2021 accounted for 70.3% of the total traffic of passengers realised in December 2019, while total traffic of passengers in 2021 accounted for 41.3% of the total traffic of passengers realised in 2019.*

*The largest traffic of passengers was recorded in the Zagreb Airport, with 178 thousand passengers, which was an increase of 336.0% compared to December 2020, when the traffic of passengers amounted to 41 thousand (the traffic of passengers amounted to 230 thousand in December 2019). This was followed with the Split Airport, with 23 thousand passengers (the traffic of passengers amounted to 8 thousand in December 2020 and to 39 thousand in December 2019), and the Dubrovnik Airport, with 12 thousand passengers (the traffic of passengers amounted to 4 thousand in December 2020 and to 35 thousand in December 2019).*

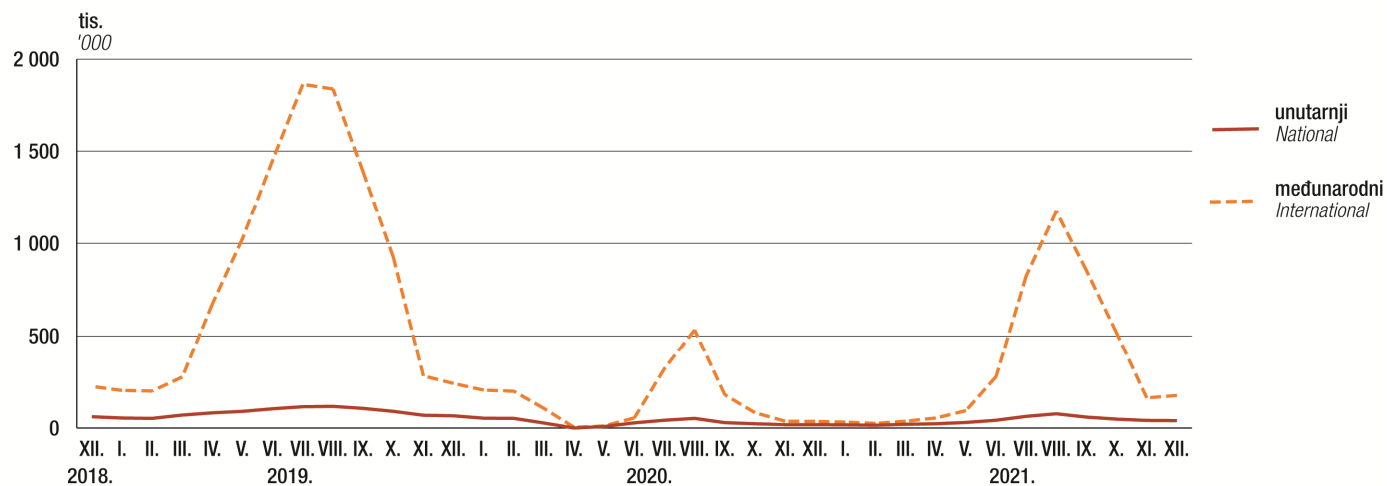
*The most significant international traffic of passengers was realised with German airports, 48 thousand passengers, which was an increase of 353.0% compared to the same period of 2020, when the traffic of passengers amounted to 11 thousand.*

*The total number of landings and take-offs in airports in December 2021 amounted to 4 653 movements, which was 101.0% more than in December 2020, when the total number of landings and take-offs in airports amounted to only 2 315 movements. The total number of landings and take-offs in airports amounted to 4 886 movements in December 2019.*

*The total traffic of freight in airports in December 2021 amounted to 882 tonnes, which was an increase of 25.5% compared to December 2020, when the total traffic of freight in airports amounted to 703 tonnes.*

*In the period from January to December 2021, there were 86 thousand landings and take-offs in Croatian airports, which was 58.2% more than in the same period of 2020. In 2021, a total of 4.7 million passengers departed from or arrived to Croatian airports, which was 121.5% more than in 2020. The total traffic of freight in airports in the period from January to December 2021 increased by 14.7% compared to the same period of 2020 and amounted to 8.8 thousand tonnes.*

# NOTES ON METHODOLOGY

## Izvori i metode prikupljanja podataka

Kumulativni podatak nije uvijek jednak zbroju pojedinačnih mjesečnih rezultata zbog zaokruživanja na tisuće.

Svrha istraživanja jest prikupiti podatke o broju svih operacija zrakoplova, prometu putnika i tereta na komercijalnim operacijama u zračnim lukama te u pristaništima Republike Hrvatske.

Jedinice promatranja i izvještajne jedinice jesu zračne luke u Republici Hrvatskoj. Podaci su prikupljeni u obliku elektroničkih setova i na obrascu PZ/M-21.

## Obuhvat

Podaci o zračnom prometu (ukupne operacije zrakoplova, promet putnika i tereta u zračnim lukama) odnose se na rad zračnih luka Zagreb, Split, Dubrovnik, Pula, Rijeka, Zadar, Osijek, Brač te zračnog pristaništa Mali Lošinj.

**Broj ukupnih operacija zrakoplova u zračnim lukama** odnosi se na broj svih (komercijalnih i nekomercijalnih) operacija slijetanja i polijetanja zrakoplova, osim državnih letova (vojska, carina, policija).

**Promet putnika u zračnim lukama** obuhvaća broj otputovalih i doputovalih putnika na komercijalnim operacijama. Isključeni su putnici u direktnom tranzitu. Putnici u direktnom tranzitu jesu putnici koji, nakon kratkog zaustavljanja, nastavljaju svoje putovanje istim zrakoplovom na letu s istim brojem leta kao let s kojega su stigli.

**Promet tereta u zračnim lukama** odnosi se na utovarenu i istovarenu robu i poštu na komercijalnim operacijama, osim prtljage putnika. Isključen je teret u direktnom tranzitu.

## Sources and methods of data collection

Cumulative data are not always equal to the sum of individual monthly results due to the rounding of numbers to the nearest thousand.

The purpose of the survey is to collect data on the number of all aircraft movements and the traffic of passengers and freight on commercial operations in airports and air landing places of the Republic of Croatia.

The observation units and reporting units are airports in the Republic of Croatia. Data are collected in the form of electronic datasets and on the PZ/M-21 form.

## Coverage

The data on air traffic (total aircraft movements, traffic of passengers and freight in airports) relate to the activities of the airports of Zagreb, Split, Dubrovnik, Pula, Rijeka, Zadar, Osijek, Brač and the air landing place of Mali Lošinj.

**The number of total aircraft movements in airports** refers to the number of all (commercial and non-commercial) operations of landing and taking-off of an aircraft, except state flights (military, customs, police).

**Traffic of passengers in airports** includes the number of passengers who have departed or arrived on commercial operations. Passengers in direct transit are excluded. Direct transit passengers are passengers who, after a short stop, continue their journey on the same aircraft on a flight having the same flight number as the flight on which they arrived.

**Traffic of freight in airports** refers to the loaded and unloaded goods and mail on commercial operations other than the baggage of passengers. The freight in direct transit is excluded.
