### Concert season for professional ensembles, orchestras and choirs

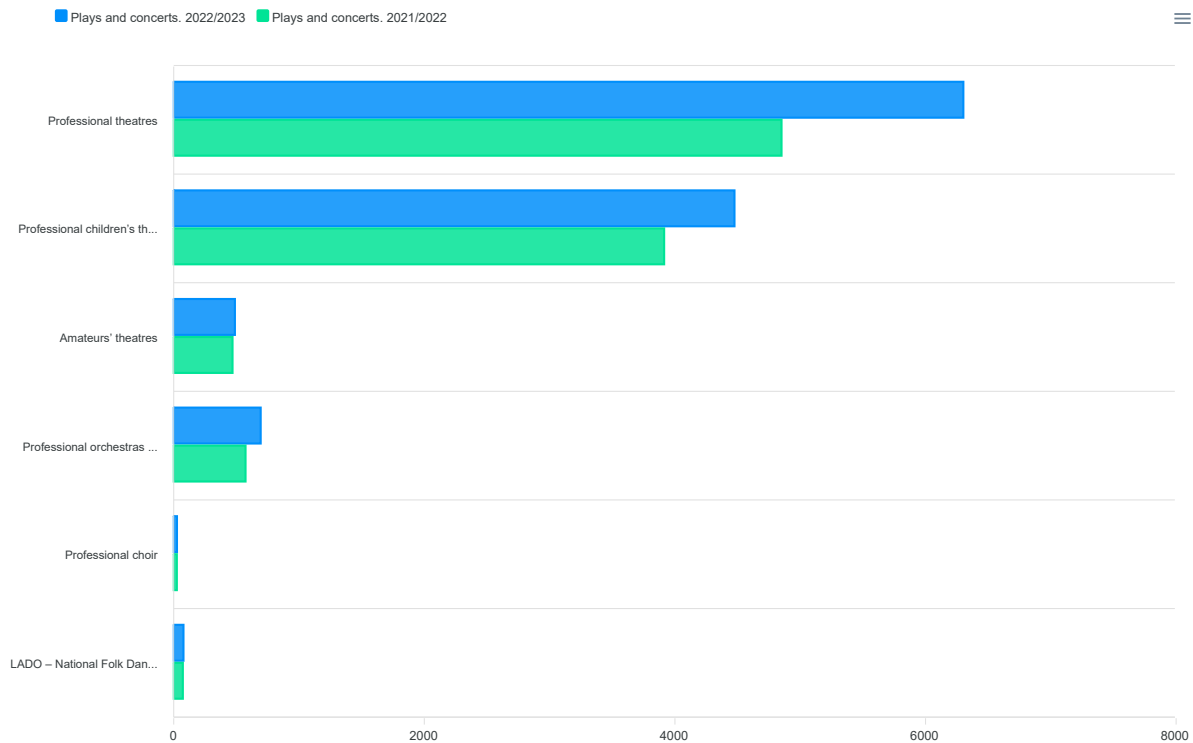
In the 2022/2023 season, 37 professional orchestras and ensembles operated, out of which six were symphony and large orchestras, seven chamber orchestras and 24 chamber ensembles. A total of **694** concerts, performances and festivities were performed, which were attended by 209 561 visitors.

Compared to the 2021/2022 season, the number of performed concerts increased by **17%** and their attendance by 28%.
