

PRAVNE OSOBE POČINITELJI KAZNENIH DJELA PREMA VRSTI ODLUKE U 2020.

LEGAL ENTITIES PERPETRATORS OF CRIMINAL OFFENCES, BY TYPE OF DECISION, 2020

U 2020. državna odvjetništva u Republici Hrvatskoj donijela su odluke u povodu prijava za 707 pravnih osoba – počinitelja kaznenih djela, što je 8,0% manje prijavljenih pravnih osoba nego u 2019. Broj optuženih pravnih osoba u odnosu na prethodnu godinu veći je za 11,7%, a broj pravnih osoba proglašenih odgovornima za 58,1%.

U 2020. broj optuženih pravnih osoba iznosio je 86, a udio pravnih osoba koje su proglašene odgovornima iznosio je 57,0% (49 pravnih osoba).

U 2020. najzastupljenija su bila kaznena djela protiv gospodarstva. Udio prijavljenih pravnih osoba za kaznena djela protiv gospodarstva iznosio je 48,4%, optuženih 58,1% a proglašenih odgovornima 67,3%.

Za pravne osobe proglašene odgovornima izrečene su novčane kazne. U odnosu na visinu izrečene novčane kazne, najučestalije su novčane kazne 10 001 – 20 000 kuna (21 pravna osoba), a potom novčane kazne 20 001 – 50 000 kuna (20 pravnih osoba).

Za pet pravnih osoba sud je donio odluku o oduzimanju imovinske koristi stečene kaznenim djelom.

In 2020, public prosecutor's offices in the Republic of Croatia decided upon crime reports for 707 legal entities – perpetrators of criminal offences, which was 8.0% less than in 2019. The number of accused legal entities increased by 11.7% and the number of legal entities recognised as responsible by 58.1%, as compared to the previous year.

In 2020, there were 86 accused legal entities, while the share of legal entities recognised as responsible was 57.0% (49 legal entities).

In 2020, criminal offences against economy were the most frequent ones. The share of reported legal entities for criminal offences against economy was 48.4%, of accused legal entities 58.1% and of legal entities recognised as responsible 67.3%.


Fines were imposed as criminal penalties for all legal entities recognised as responsible. Regarding the amount of pronounced fines, the most frequent ones were those ranging between 10 001 and 20 000 kuna (21 legal entities) and between 20 001 and 50 000 kuna (20 legal entities).

There were five legal entities for which a court decided to confiscate a pecuniary benefit acquired by the criminal offence.





G-3. ODLUKE SUDova U POVODU OPTUŽBE



METODOLOŠKA OBJAŠNJENJA

Izvor i metode prikupljanja podataka

Na temelju Zakona o službenoj statistici (NN, br. 25/20.), podaci o prijavljenim i optuženim pravnim osobama te pravnim osobama proglašenima odgovornima prikupljaju se redovitim statističkim istraživanjima koja se koriste sljedećim statističkim izvještajima: Statistički izvještaj za pravnu osobu prema kojoj je postupak po kaznenoj prijavi i prethodni postupak završen (obrazac SP-1) i Statistički izvještaj za optuženu pravnu osobu prema kojoj je kazneni postupak pravomočno završen (obrazac SP-2).

Statističke izvještaje ispunjavaju nadležna državna odvjetništva nakon donošenja konačne odluke te županijski i općinski sudovi koji sude u prvom stupnju nakon što je postupak pravomočno završen. Jedinice promatrana jesu pravne osobe koje su počinitelji kaznenih djela.

NOTES ON METHODOLOGY

Source and methods of data collection

On the basis of the Official Statistics Act (NN, No. 25/20), data on reported and accused legal entities as well as those recognised as responsible are collected by regular statistical surveys, in which the following statistical reports are used: the Statistical Report for Legal Entities against Which Proceedings Based on Crime Report and Interlocutory Proceedings Have Been Concluded (SP-1 form) and the Statistical Report for Accused Legal Entities against Which Criminal Proceedings Have Been Validly Concluded (SP-2 form).

Statistical reports are filled in by competent public prosecutors' offices after the final decision has taken place as well as county and municipal courts of the first instance that act after the criminal procedure has been validly concluded. Observation units are legal entities – perpetrators of criminal offences.

Zakon o odgovornosti pravnih osoba za kaznena djela (NN, br. 151/03., 110/07., 45/11. i 143/12.) stupio je na snagu 24. ožujka 2004. U statističkim istraživanjima primjenjuje se od 1. siječnja 2005.

Dana 1. siječnja 2013. godine stupio je na snagu novi Kazneni zakon (NN, br. 125/11., 144/12., 56/15., 61/15. – ispravak, 101/17., 118/18. i 126/19.). Navedenim zakonom, osim što su uvedeni novi i preinačeni postojeći opći instituti materijalnog kaznenog prava, propisan je i novi katalog kaznenih djela.

Obuhvat

Statističkim istraživanjima obuhvaćene su sve prijavljene, optužene te pravne osobe proglašene odgovornima, kao počinatelji kaznenih djela.

Definicije

Prijavljena pravna osoba jest svaka pravna osoba prema kojoj je postupak po kaznenoj prijavi i prethodni postupak završen odlukom kojom je odbačena prijava, prekinuta istraga, obustavljena istraga ili podnesena optužnica.

Optužena pravna osoba jest svaka pravna osoba prema kojoj je kazneni postupak pravomočno završen odlukom suda o: odbačaju optužbe, obustavi kaznenog postupka, oslobađajućoj ili odbijajućoj presudi ili je pravna osoba proglašena odgovornom.

Pravna osoba proglašena odgovornom jest svaka pravna osoba za koju je kazneni postupak pravomočno završen odlukom suda kojom je pravna osoba proglašena odgovornom.

The Act on the Responsibility of Legal Entities for Criminal Offences (NN, Nos 151/03, 110/07, 45/11 and 143/12) was put into effect on 24 March 2004 and it has been applied in statistical surveys since 1 January 2005.

On 1 January 2013, the new Penal Code (NN, Nos 125/11, 144/12, 56/15, 61/15 – correction, 101/17, 118/18 and 126/19) entered into force. This Code, besides implementing new and modifying existing general institutes of material criminal law, prescribes a new catalogue of criminal offences.

Coverage

Statistical surveys cover all legal entities – perpetrators of criminal offences, whether reported, accused or recognised as responsible.

Definitions

Reported legal entity is every legal entity against which proceedings based on crime report and interlocutory proceedings have been concluded with a decision by which: the crime report has been rejected, the investigation has been interrupted, investigation has been terminated, or an indictment has been submitted.

Accused legal entity is every legal entity against which criminal proceedings have been concluded with a valid court decision, by which the indictment has been dropped, proceedings have been terminated, a legal entity has been acquitted, an accusation has been rejected or a legal entity has been recognised as responsible.

Legal entity recognised as responsible is every legal entity against which criminal proceedings have been concluded with a valid court decision by which a legal entity has been recognised as responsible.
